REGISTRATION AND REGULATION

1. This contest is intended for domestic producers, international importers and bottlers.
 - 1.1. In case that it has conflict between brands of producers, importers or fillers, the preference of participation will be given according registration order.
2. Each participant will be able to compete with up to 03 Extra Virgin olive Oil labels. Each sample must have a registration form (Anex I), and a technician report with the following tests:
 - **Free Acidity expressed as % weight of oleic acid,**
 - **Number of peroxide,**
 - **K232mm,**
 - **K270mm e**
 - **ΔK**The report should be issued by the country of olive oil origin.
3. The samples will be of responsibility at JKPG Media (ExpoAzeite), being the result kept in secret until announce of the results.
4. The samples and the original report will be received at JKPG Media (ExpoAzeite) office from January 01st – June 10th, 2017, All oils **MUST BE SHIPPED PREPAID**, the minimum amount is 1.5 liters divided into 3 bottles of 500ml from the same batch of manufacture. JKPG Media (ExpoAzeite) will not be responsible for any customs or shipping charges. Don't use FEDEX, UPS or other curries company unless you pre pay the taxes. Use Regular Mail services.

Along with the samples the participant shall attach prove letter as listed below and write out the packaging OLIVE OIL (Large and visible), and the delcartion bellow in Portugues.

5. The samples will be codified JKPG Media (ExpoAzeite) office; one of them will be stored for eventual embezzlement or necessity of against-analysis, another one, will be used for flavors tests and the last one will be used for photos, showroom and other media necessities.
6. Awarding will only be confirmed if the olive oil purity could be certified.
7. The Jury of the competition will be composed at least by:
 - **An invited “Taster” From Spain, Portugal or Italy.**
 - **3 Invited “Tasters” From Brazil.**
8. The jury will review and award the oils considered suitable. The jury will make a synthesis of the results only by means of mathematical statistics, specifically the median. It will not be published and public, neither the ranking of the participating producers, nor the score obtained in each sample, it will be available only the cast of producers. The vote forms, and any final assessments of each sample, are reserved to the jury but it may be issued to producers through application of those concerned. **The jury decision is final.**
9. The awarding will be assigned as follows:
Harmony (Fruit, Bitter e Spice) - Extra Virgem
 - Gold Certified for 1st place southern hemisphere and 1st place Northern Hemisphere;
 - Silver Certified for 2nd place southern hemisphere and 2nd place Northern Hemisphere;
 - Brass Certified for 3rd place southern hemisphere and 3rd place Northern Hemisphere.
10. The results and certified will be announced during Expoazeite- Conserve, Olive and Olive Oil International Fair - SP 2017 (July 10th to 11th), the programming will be advertised at the event page (www.expoazeite.com.br).
11. The application will be considered complete only following procedures:
 - Registration form filled (attached I), one for each oil,
 - ORIGINAL TECHNICAL REPORT,
 - Payment of **Us\$150,00** for each registration for ExpoAzeite exhibitors and **Us\$350,00** for the others.
 - Receiving of 3 bottles of 500ml for each registration.
12. The organization reserves the right to modify the current policy at any time where necessary.
